THE GRANTOR, LAWYERS TITLE INSURANCE CORPORATION, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment recited below, hereby grants and conveys, without warranty to: BANK ONE, NATIONAL ASSOCIATION, AS TRUSTEE, GRANTEE, that real property, situated in the County of Skagit, State of Washington, described as follows:

BANK ONE, NATIONAL ASSOCIATION, AS TRUSTEE, being that the holder of the indebtedness secured by said Deed of Trust, delivered to said Trustee a written request directing said Trustee or his authorized agent to sell the described property in accordance with law and the terms of said Deed of Trust.
- The defaults specified in the "Notice of Default" not having been cured, the Trustee, in compliance with the terms of said Deed of Trust, Recorded on July 5, 2000, Instrument No. 200007050073 in the office of the Auditor of Skagit County, Washington, a "Notice of Trustee's Sale" of said property which was Recorded on 11/13/2003, as Instrument # 200311130057, book # -, page # -.
- 7. The Trustee, in its aforesaid "Notice of Trustee's Sale," fixed the place of sale as AT THE MAIN ENTRANCE TO THE SUPERIOR COURTHOUSE. 205 W. KINCAID STREET, MT.
