- 2) The court finds The Respondent is in Contempt for allowing the life insurance to lapse. Respondent shall ~~provide~~ obtain life insurance with American Express as submitted by Petitioner by February 1, 2004, as a purging mechanism. Respondent shall further purge contempt by providing proof of insurance for 2/1/04 and that Petitioner is named on the policy as trustee, with children as beneficiaries and provide proof that he has authorized in writing that Petitioner shall have ongoing notice of any lapse & access to policy information. Such policy shall be a minimum of a 10 year term and in the amount of \$350,000.00.
- 3) The difference in \$1166.2 judgment and Petitioner's requested \$2524.61 shall be submitted to arbitration based upon the dispute between the parties. The prevailing party at arbitration shall receive their
