ENCROACHMENT AGREEMENT

This Agreement is made and entered into by and between the City of Anacortes, a municipal corporation, hereinafter referred to as "CITY" and Mark & Mary Kiser – Everett & Linda Linholm, hereinafter referred to as "OWNER".

Whereas, OWNERS, Mark & Mary Kiser – Everett & Linda Linholm, the owner's of the following described real estate located within the City of Anacortes, Skagit County, Washington, also known as 807 21st Street.

807 21st Street – Nelson's to Anacortes lots 7&8 Block 8, Parcel Number P58068 / 3807-008-008-0004

Whereas, the Owners has placed certain improvements in the right of way adjacent to said property consisting of:

To encroach 21 feet by 29 feet on the SW corner of the property for a paved radius for egress and placement of two picnic tables.

Now, therefore, parties hereby agree as follows:

Whereas, the City is agreeable to allowing said encroachment on certain terms and standard conditions:

Standard Conditions:

- 1. The enclosed agreement must be signed and notarized by each property owner(s) and returned to Cherri Kahns, Executive Secretary.
- 2. The Owner(s) agree to comply with all applicable ordinances, laws and codes in constructing the encroachment and further agree to remove the said encroachment within a reasonable time upon request by the City of Anacortes or a duly franchised public utility. The Owner(s) understand and agree that all costs incurred in removing said improvements shall be at the Owner's sole expense.
- 3. The Owner(s) agree to indemnify and hold the City harmless from any claims for damages resulting from construction, maintenance or existence of those improvements encroaching into said right-of-way.
- 4. The Owner(s) shall not obstruct water meters or other public or private facilities except as approved in this agreement.
- 5. The Owner(s) shall ensure that any public or private utilities are not impacted or damaged by construction or use.
- 6. The Owner(s) shall leave a minimum of 48 inches of clearance between the curb or edge of street and any above grade construction.
- 7. The construction and use shall not create clear view obstructions at intersections or private property access.

Special Conditions

- 1. The City would like to video and repair sewer line prior to construction.
- 2. The City retains the right of way for future expansion of Q Avenue and/or utility construction.
- 3. The City retains ownership of Water Quality Swale.
- 4. Developer to install 4 picnic benches for public use. The 4 picnic benches shall be posted with signs for public use.
