A 15-foot wide non-exclusive easement for ingress, egress and utilities over, across and under a strip of land centered upon an existing driveway running Southeasterly from the Westerlymost Northwest corner of Lot C of that certain Survey recorded August 21, 2003 as Skagit County Auditor's File No. 200308210049 to the Northwesterly right-of-way of the Deception Road as delineated on said Survey; being a portion of Blocks 190 and 213 "Map of Fidalgo City, Skagit Co.
