

- b.) No lots shall be used for commercial business or manufacturing purposes except Lots 1, 2, 3, 27, 38, 29 and 30 in Block 1, and Lots 4, 5, 6 and 7 in Block 2.
- C. Right of the State of Washington in and to that portion, if any, of the property herein described which lies below the line of ordinary high water of Lake Cavanaugh.
- D. Any prohibition of or limitation of use, occupancy or improvement of the land resulting from the rights of the public or riparian owners to use any portion which is now, or has formerly been, covered by water.
