NATIONWIDE TITLE CLEARING, a Washington State corp., as Trustee under said Deed of Trust.

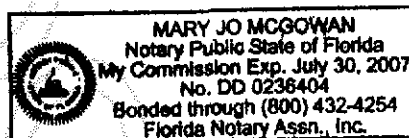

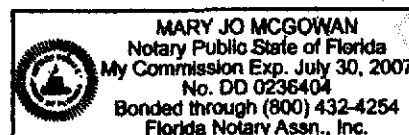
