RELINQUISHMENT of EASEMENT And GRANT of EASEMENT

RECITALS

The parties to this instrument are Jefferson Land Company, LLC, a Washington limited liability company, and James N. Scott and Mary S. Scott, husband and wife.

Jefferson Land Company, LLC, a Washington limited liability company, is owner of certain real property located in Skagit County, Washington, described on EXHIBIT A, attached hereto, hereafter referred to as the "Jefferson property."

A portion of the property is encumbered by a drainage easement in favor of the owners of Tracts 1, 2 and 3 of Short Plat No. MV-4-84, recorded April 10, 1984, under Auditor's File No. 8404200015, records of Skagit County, Washington, and adjoining property owned by James N. Scott and Mary S. Scott, husband and wife, hereafter referred to as the "Scott property," which easement was granted to James N. Scott and Mary S. Scott, husband and wife, by deed recorded April 12, 1994, under Auditor's File No. 9404120131, records of Skagit County, Washington, hereafter referred to as the "1994 drainage easement."

The parties hereto now wish to relinquish a portion of the easement encumbering the Jefferson property and replace that relinquished portion with a new easement encumbering the Jefferson property for the benefit of the Scott property.

RELINQUISHMENT OF EASEMENT

THEREFORE, for the purpose of terminating and relinquishing that portion of the 1994 drainage easement described on EXHIBIT B (the "relinquishment area"), which is attached hereto and, by this reference, incorporated herein, and to place said relinquishment on the public record, James N. Scott and Mary S. Scott, husband and wife, hereby release and relinquish all rights in that portion of the 1994 easement described on EXHIBIT B, and quit claim all interest in the property described on EXHIBIT B to Jefferson Land Company, LLC.

GRANT OF EASEMENT

In consideration of the release of the above described portion of the 1994 drainage easement, the mutual covenants contained herein, and for no monetary consideration, Jefferson Land Company, LLC, hereby grants and conveys to the present and future owners of Tracts 1, 2 and 3 of Mount Vernon Short Plat No. MV-4-84, recorded April 10, 1984, under Auditor's File No. 8404200015, records of Skagit County, Washington, and adjoining property owned by James N. Scott and Mary S. Scott, husband and wife, a non-exclusive easement over under and through that portion of Tract 3 of said Short Plat described on EXHIBIT C, the "easement area" for purposes of drainage, including the right to install, maintain, repair and replace a drainage system within the easement area, and together with right of ingress and egress over the adjoining Jefferson property for purposes of installing, maintaining, repairing or replacing a drainage system within the easement area. The easement is granted for the benefit of Tracts 1, 2, and 3 of Short Plat MV-4-84 and for the benefit of adjoining real property owned by James N. Scott and Mary S. Scott, husband and wife.

The easement and covenants herein shall run with the land and shall be binding on the parties hereto, their heirs, successors or assigns, and all subsequent owners thereof.
