To protect the security of this Deed of Trust, Grantor covenants and agrees:

- 1. Repair & Maintenance: To keep the property in good condition and repair, to permit no waste thereof, to complete any building, structure or improvement being built or about to be built thereon, to restore promptly any building, structure or improvement thereon which may be damaged or destroyed, and to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the property.
- Payment of Taxes: To pay before delinquent all lawful taxes and assessments upon the property, to keep the property free and clear
 of all other charges, liens or encumbrances impairing the security of this Deed of Trust.
- To defend any action or proceeding purporting to affect the security hereof or the rights or powers of Defense of Title: Beneficiary or Trustee, and to pay all costs and expenses, including cost of title search and attorney's fees in a reasonable amount, in any such action or proceeding, and in any suit brought by Beneficiary to foreclose this Deed of Trust.
- Costs & Expenses: To pay all costs, fees and expenses in connection with this Deed of Trust, including the expenses of Trustee incurred in enforcing the obligation secured hereby and Trustee's attorney's fees actually incurred, as provided by status.
- Should Grantor fail to pay when due any taxes, assessments, liens, encumbrances or other charges against the 5. <u>Failure to Pay:</u> Should Grantor fail to pay when due any taxes, assessments, liens, encumbrances or other charges against the property here in above described, Beneficiary may pay the same and the amount so paid, with interest at the highest rate allowed by the laws of the State of Washington, shall be added to and become a part of the debt secured in this Deed of Trust.

- 8. <u>Forbearance:</u> Any forbearance by Beneficiary in exercising any rights or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy. The payment of taxes or other liens or charges by Beneficiary shall not be a waiver of Beneficiary's right to accelerate the maturity of the indebtedness secured by this Deed of Trust.
- Remedies: All remedies provided in the Deed of Trust are distinct and cumulative to any other right or remedy under this Deed of
 Trust or afforded by law or equity and may be exercised concurrently, independently or successively.
- 10. Binding Effect: The covenants and agreements herein contained shall bind, and the rights hereunder shall insure to the respective successors and assigns of Beneficiary and Grantor, subject to the provisions of Paragraph 14 hereof. All Covenants and agreements of Grantor shall be joint and several. The captions and headings of the paragraphs of this Deed of Trust are for convenience only and are not to be used to interpret or define the provisions hereof.
- 11. Notice: Except for any notice required under applicable law to be given in another manner. (a) any notice to Grantor provided for in this Deed of Trust shall be given by mailing such notice, postage prepaid, addressed to Grantor at the address shown herein or such other address as Grantor may designate by notice to Beneficiary as provided herein, (b) any notice to Beneficiary shall be given by first-class mail, postage prepaid, to Beneficiary's address stated herein or to such other address as Beneficiary may designate by notice to Grantor as provided herein. Any notice provided for in this Deed of Trust should be deemed to have been given to Grantor or Beneficiary when given in the manner designated herein
