A 100' radius circle in Lot 1 of said Short Plat whose center is described as follows:

Beginning at the northeast corner of said Lot 1; thence S25°28'50"S, along the easterly line of said Lot 1 a distance of 461.19 feet; thence S64°31'10"W, perpendicular to said easterly line, a distance of 411.85 feet to said radius point.

### Well Easement Covenant

The owner of Lot 2 on Short Plat PL03-0533, recorded under Auditor's File No 200310300119, Skagit County, Washington, herein known as the Grantor agree and covenant that said Grantor, his heirs, successors and assigns will not construct, maintain or suffer to be constructed or maintained upon said land of the Grantor and within 100 feet of the well, either in place or to be built, so long as the same is operated to furnish water for said Lot 1 of said Short Plat, any of the following: cesspools, sewers, privies, septic tanks, drainfields, manure piles, garbage of any kind of description, barns, chicken houses, rabbit hutches, pigpens, or other enclosures for the keeping or maintenance of fowls or animals, or storage of liquid or dry chemicals, herbicides or insecticides.

These covenants shall run with the land and shall be binding on all parties having or acquiring any right, title or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
