The North 1/2 of the Southeast 1/4 of the Southeast 1/4 of Section 7, Township 33 North, Range 4 East, W.M., EXCEPT Great Northern Railroad right of way; AND EXCEPT Drainage Ditch No. 17 right of way as condemned by decree entered November 15, 1945 in Skagit County Superior Court Cause No. 17539; AND EXCEPT those portions thereof conveyed to the State of Washington for Highway purposes by deeds recorded April 15, 1955 and May 4, 1972 under Auditor's File Nos. 516233 and 767815, AND EXCEPT the following described tract:
