A. Easement provision set forth on the face of the Plat, as follows:

"An easement is hereby reserved for and granted to Puget Sound Power & Light Company and General Telephone, Nationwide Cablevision and their respective successors and assigns under and upon the exterior seven (7) feet parallel and adjacent to the street frontage of all lots, in which to install, lay, construct, renew, operate and facilities and other equipment for the purpose of serving the cablevision and other property with electric, telephone and cablevision service, together with the right to enter upon the lots shown on the face of this Plat."
