**SPECIAL POWER OF ATTORNEY
FOR SALE OF REAL PROPERTY**

PREAMBLE: This is a **MILITARY POWER OF ATTORNEY** prepared pursuant to Title 10, United States Code, § 1044b, and executed by a person authorized to receive legal assistance from the military services. Federal law exempts this power of attorney from any requirement of form, substance, formality, or recording that is prescribed for powers of attorney by the laws of a state, the District of Columbia, or a territory, commonwealth, or possession of the United States. Federal law specifies that this power of attorney shall be given the same legal effect as a power of attorney prepared and executed in accordance with the laws of the jurisdiction where it is presented.

KNOW ALL PERSONS BY THESE PRESENTS:

That I, DANIEL A. JONES, currently a resident of the State of WA, by this document do make and appoint KATHRYN G. JONES, whose present address is 6 THOMAS DR WADINE RIVER, NY, as my true and lawful attorney to do and execute (or to act with persons jointly interested with myself therein in the doing or execution of) any or all of the following acts or things:

To bargain, seal, set over, assign and convey, using the standard of a reasonable seller under no compulsion to sell and engaging in an arms length bargaining transaction, unto any person of his/her choice, all my right, title and interest in any or all of that house and tract or parcel of land located in the County of SKAGIT, State of WA, and to convey by THE SELLING OF THE HOUSE, to receive payment of the purchase money on my behalf for the property in any manner in which my said attorney in fact shall deem wise, (**OPTIONAL CLAUSE - CROSS OUT IF NOT NEEDED** to transmit said monies to me at NFCU ACCOUNT), and to sign, seal, execute and deliver any and all deeds, contracts, or other documents necessary to carry out the foregoing. 

I FURTHER DECLARE that any act or thing lawfully done hereunder by my said attorney shall be binding on myself and my heirs, legal and personal representatives and assigns, whether the same shall have been done either before or after my death, or other revocation of this instrument, unless and until reliable intelligence or notice thereof shall have been received by my said attorney.

FURTHER, this power of attorney shall remain in full force and effect until 20 SEPT., 2005, unless sooner revoked by me, provided, however, that such prior revocation shall be of no effect in respect to parties acting or things done in reliance hereon prior to receipt by them of such notice of revocation as may be prescribed by law.


