Termination of Lease Agreement

I. RECITALS

WHEREAS, the Port of Skagit County, a Washington municipal corporation ("Port"), is the Lessor with respect to a Lease Agreement dated July 19, 1995 ("Lease"), concerning Lot 37 and a portion of Lot 36, at the Skagit Regional Airport Binding Site Plan, recorded under Auditor's file number 860825002 (said property now identified as Lot 27 in Amended Skagit Regional Airport Binding Site Plan – Phase I, recorded under Auditor's file number 200303040030 and hereinafter referred to as Lot 27), as legally described in Exhibit "A" hereto ("Real Property"), leased by TTM Technologies, F/K/A Pacific Circuits, Inc., Lessee ("TTM"); and

WHEREAS, the Port is buying building improvements located on the Real Property from TTM and has agreed at closing of such sale to terminate the TTM Lease;

H. AGREEMENT

NOW THEREFORE in consideration of the mutual promises contained herein and other good and valuable consideration, the adequacy of which the parties acknowledge, the Port and TTM agree that:

- A. <u>Termination</u>. The Lease is hereby terminated as of the <u>14th</u> day of <u>October</u>, 2004 ("Termination Date"), and TTM shall have no further obligations under the Lease thereafter, except for those terms which survive as set forth below.
- B. <u>Survival of Terms</u>. The following provisions of the Lease set forth in the table below, to the extent that any rights or liabilities have accrued there under no later than the Termination Date, shall survive the termination of the Lease:

Paragraph 9, "Hold Harmless Provisions, Liability and Indemnity," except that (1) liability for hazardous waste shall be controlled by the provisions in the purchase and sale agreement between the parties for the sale of the improvements; and (2) TTM shall not be required to maintain insurance post closing.

Paragraph 12, "Disposition of Improvements at End of Lease," except for Lessee's obligation to restore the premises.

Paragraph 16, "Utilities."

Paragraph 18, "Liens."

Paragraph 23, "Costs and Attorneys' Fees."

Paragraph 34, "Notices."

- C. <u>Tenant's Interim Obligations</u>. All of the provisions of the Lease shall remain in effect through the Termination Date, including, but not limited to, Tenant's obligations to pay rent and maintain the premises in accordance with the provisions of the Lease.
- D. <u>Vacation of the Premises</u>. Tenant shall immediately vacate the Real Property by or before the Termination Date.
- E. <u>Effectiveness</u>. This agreement shall be effective after execution by both parties and upon recordation hereof. This agreement may be executed in counterparts.
