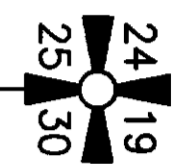

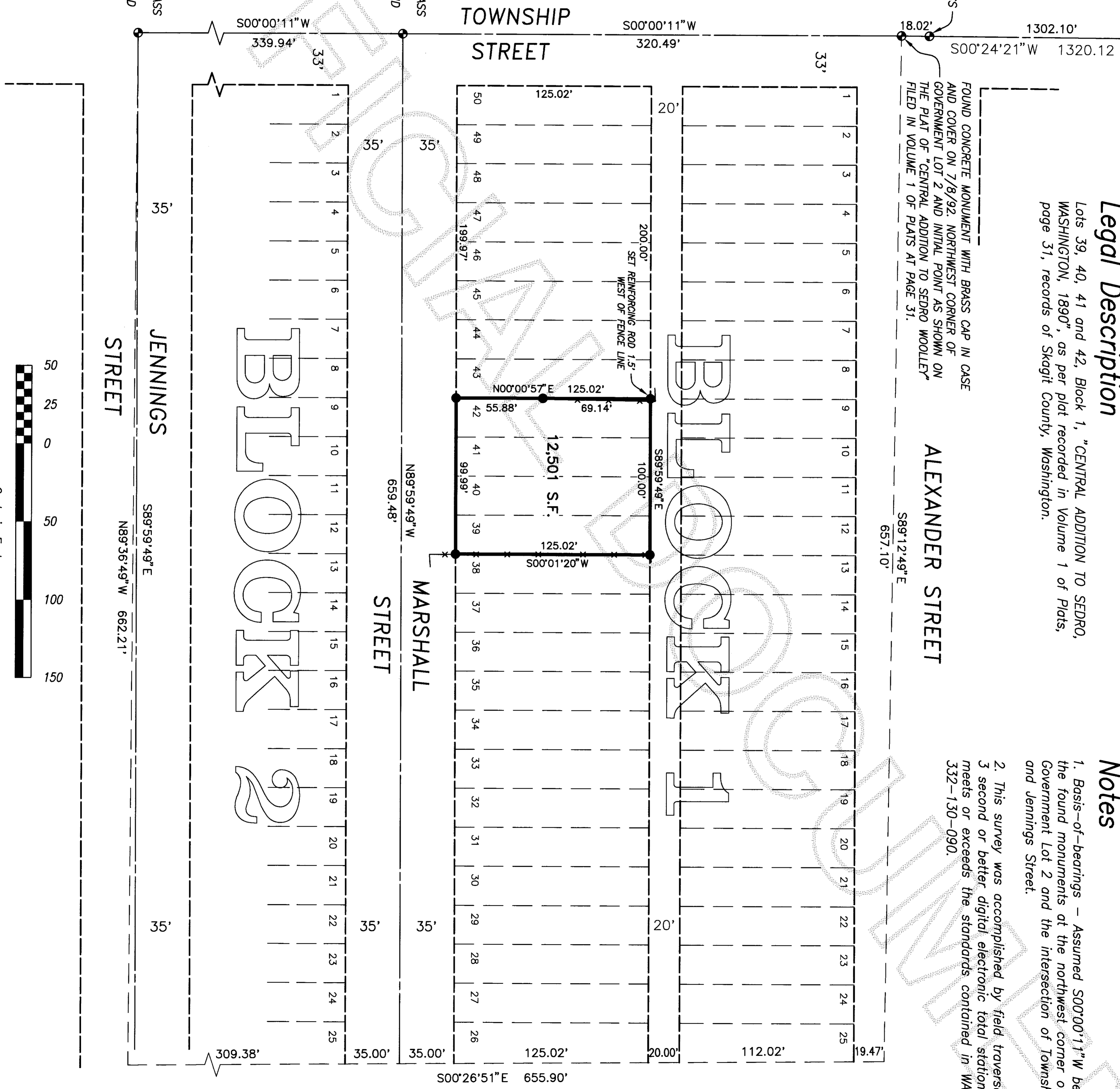
**Notes**
