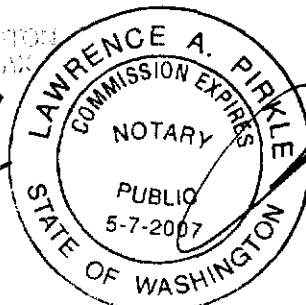

Beginning at a point on the North line of said subdivision, which point bears South 89°38'30" East a distance of 300.05 feet from the point of intersection of said North line of said subdivision with the East line of Riverside Drive (Old Highway 99); thence South 0°40'15" East along the East lines, and said lines extended North of that certain tract sold under contract to Max W.
