



EXHIBIT "A"

All that portion of the hereinafter described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 95+00 on the SR 9 line survey of SR 9, Big Lake Northwest and 130 feet northeasterly therefrom; thence northeasterly to a point opposite said HES 95+00 and 180 feet northeasterly therefrom; thence southeasterly parallel with said line survey to a point opposite HES 97+00 thereon; thence southwesterly to a point opposite said HES 97+00 and 30 feet northeasterly therefrom; thence northwesterly parallel with said line survey to a point opposite HES 96+50 thereon; thence northeasterly to a point opposite said HES 96+50 and 130 feet northeasterly therefrom; thence northwesterly parallel with said line survey to the point of beginning.

PARCEL "A"

That portion of the easterly half of that certain 100-foot wide right-of-way conveyed to the Seattle Lake Shore and Eastern Railway Company by deed recorded May 12, 1890 in Volume 9 of Deeds, Page 750 lying within the southwest quarter of the northwest quarter of Section 25, Township 34 North, Range 4 East, W.M. and that portion of the southwest quarter of the northwest quarter of Section 25, Township 34 North, Range 4 East, W.M. lying northeasterly of that certain 100-foot wide right-of-way conveyed to the Seattle Lake Shore and Eastern Railway Company by deed recorded May 12, 1890 in Volume 9 of Deeds, page 750

The lands herein described contain an area of 12,500 square feet, more or less, the specific details concerning all of which are to be found in that certain map of definite location now of record and on file in the office of the Secretary of Transportation at Olympia, and bearing date of approval December 13, 1935, and revised July 2, 2004.
