EASEMENT

IN CONSIDERATION of the sum of TEN DOLLARS (\$10.00). receipt of which is hereby acknowledged, ALAN LANGLEY and CAROL I. LANGLEY, husband and wife, hereafter referred to as Grantors, do hereby grant and convey unto ALAN LANGLEY and CAROL I. LANGLEY, hereinafter referred to as Grantees. a 10 foot wide easement on Lot C to install, maintain, inspect, operate, repair, replace, alter and/or remove, electrical line, telephone line, and cable line services, upon, over and through from the west power pole on Samish Island Road, diagonally north east to the border of Lot B (described in Exhibit A hereof to benefit Lot B hereof.)

Together with the right of ingress and egress to and from said line for the purposes aforesaid.

Grantors shall have the right to use and enjoy the described premises, except as to the rights herein granted. Grantors agree not to build, create or construct and to prevent to be built, created or constructed any obstruction, building, engineering works or other structures that would interfere with said Services or Grantee's rights hereunder.

Grantees shall have the right to assign this grant in whole or in part and this grant shall be considered and construed as running with the land to which electrical service is being provided.

It is agreed that this easement covers all of the agreements between the parties hereto and that no representations or statements, verbal or written, have been made so as to modify or add to or change the terms of this agreement.

The terms, conditions and provisions of this easement shall extend to and be binding upon the heirs, executors, administrators, personal representatives, successors and assigns of the parties hereto.


