DECLARATION OF EASEMENT

LEGAL DESCRIPTION:

<u>Parcel 1 (Tennefoss Property)</u>: Lot 35, "SKYLINE NO. 5," as per plat recorded in Volume 9 of Plats, pages 56 through 58, inclusive, records of Skagit County, Washington.

<u>Parcel 2 (Balyeat Property)</u>: Lot 34, "SKYLINE NO. 5," as per plat recorded in Volume 9 of Plats, pages 56 through 58, inclusive, records of Skagit County, Washington.

GRANTORS, BJARNE L. TENNEFOSS and BETH R. TENNEFOSS, husband and wife, in consideration of One Dollar and no other consideration, convey and quit claim unto DAVID V. BALYEAT and SHARON L. BALYEAT, husband and wife, the GRANTEES a non-exclusive five (5) foot easement over, under, and across the southern five (5) feet of the property described as Parcel 1 above for the use and benefit of Grantees' property described as Parcel 2 above. Said easement shall be adjacent to the retaining wall on the northern boundary of Grantees' property and shall be upon the following terms and conditions:

1. Said easement shall be for the purpose of installing, maintaining, repairing, and replacing a four (4) inch storm drainage line and purposes incidental thereto.

- 2. Grantees agree to provide a "T" every twenty (20) feet along said drainage pipe to allow access to the same by Grantors for the drainage of Grantors' property.
- Grantees agree to restore Grantors property to its prior condition in exercising the easement rights created by this declaration.
- The easement created by this declaration shall be binding upon the parties heirs, successors and assigns.
- 5. Grantors shall retain the right to make improvements to the property covered by this easement. These improvements include, but are not limited to: landscaping, paving, fence, and garden shed.
- Grantees shall ensure that there is no conflict or interference with any easement or utilities that may lie in the area covered by the easement.
- 7. As the easement is for Grantees' benefit, required repairs or modifications shall be at Grantees' cost, except for repairs or modifications caused by Grantors or for Grantors' benefit.
