Three non-exclusive well protection zone easements over, across and under those portions of Lots 1, 2, 3, and 4 of Short Plat No. 91-0024, approved June 11, 2004 as Auditor's File No. 200406110114, records of Skagit County, Washington, being portions of the Northwest ¼ of Section 7, Township 36 North, Range 4 East, W.M., lying within a 100-foot radius of the asbuilt location of each well to be drilled at the three approximate locations:

Well A: To be located and drilled at a point within said Lot 2 that lies approximately

41 feet South and 86 feet West of the Northeast corner of said Lot 2.

Well B: To be located and drilled at a point within said Lot 3 that lies approximately

22 feet South and 66 feet West of the Northeast corner of said Lot 3.

Well C: To be located and drilled at a point within said Lot 4 that lies approximately

38 feet South and 6 feet West of the Northeast corner of said Lot 4.

All three easements are to be appurtenant to the lot on which each well lies and are to comply with present and future Skagit County Health Department regulations for well protection zones.
