Default. Upon review of the files and records herein, and the declaration plaintiff's 3.1 legal counsel of record, it is hereby ordered, adjudged and decreed that Defendants WABI FISHING COMPANY, a Washington state corporation; and LEO R. PALMER, a married man; and the Marital Community of LEO R. PALMER and JANE DOE PALMER are in default in this matter this 7th day of August, 2003 by reason of failing to file and serve their notice of appearance and to answer the complaint of the plaintiff herein within the time permitted by law to so do.

IV. ADJUDICATION

ON THE BASIS OF THE FOREGOING, IT IS ORDERED, ADJUDGED, AND DECREED

Judgment. Plaintiff is awarded judgment against the Defendants WABI FISHING 4.1 COMPANY, a Washington state corporation; and LEO R. PALMER, a married man; and the Marital Community of LEO R. PALMER and JANE DOE PALMER, jointly and severally, in the amount of \$119,441.34 in principal for failure to pay or timely pay monies due on that certain promissory note dated as of April 25, 2002; together with interest thereon at the rate of 12% per annum to the date this action was filed in the amount of \$5,010.43; and interest thereon at the default rate of 18% per annum from July 17, 2003 as provided by written agreement of defendant in the amount of \$1,292.46 to the date of this judgment; and 4*0*0 i*0*0 for plaintiff's statutory attorney's fees and \$200.00 for filing and service of process costs incurred by plaintiff. Post judgment interest shall accrue at the rate of 12% per annum pursuant to RCW 4.56.110(2).
