A sale of the corporation, limited liability company or partnership interest greater than 49% of the voting stock, partnership interest, or member interest after date of the recording the Deed of Trust or dilution of the current voting stock, partnership or member interests through issuance of additional shares or interest shall likewise constitutes a "transfer". In the case of conveyance or contract to convey, the interest shall likewise increase to the default amount or the holder may consent to the conveyance or contract to convey and increase the interest rate provided for herein. However, this option shall not be exercised by Beneficiary if exercise is prohibited by federal or Washington State law.
