Lots 1 through 9, inclusive, Block 192, "MAP OF FIDALGO CITY, SKAGIT CO., WASHINGTON", as per plat recorded in Volume 2 of Plats, pages 113 and 114, records of Skagit County, Washington.

TOGETHER WITH the East 1/2 of the vacated alley adjacent to said lots.

TOGETHER WITH the West 1/2 of vacated Carlyle Street adjacent to said Lots 1 through 9, inclusive, and adjacent to the South 1/2 of vacated 2nd Street.

TOGETHER WITH the South 1/2 of vacated 2nd Street adjacent to Lot 1, and adjacent to the East 1/2 of the vacated alley.
