**DEED OF RIGHT TO USE LAND FOR PUBLIC  
AQUATIC LANDS ACCESS PURPOSES  
(Easement for Public Use)**

**GRANTOR:** SKAGIT COUNTY DIKE DISTRICT NO. 12,  
a Washington special purpose district, (a/k/a  
SKAGIT COUNTY CONSOLIDATED DIKE  
AND DRAINAGE DISTRICT NO. 12)

**GRANTEE:** THE STATE OF WASHINGTON,

The Grantor, SKAGIT COUNTY DIKE DISTRICT NO. 12, a Washington special purpose district, (a/k/a SKAGIT COUNTY CONSOLIDATED DIKE AND DRAINAGE DISTRICT NO. 12), for and in consideration of monies coming in whole or in part from the Aquatic Lands Enhancement Account of the General Fund of the State of Washington (State) and in fulfillment of terms of the Project Agreement identified below, conveys and grants to the State of Washington, individually and as the representative of all the people of the State, the right to use the real property described below forever for the aquatic access purposes described in the Project Agreement entered into between the Grantor and the State of Washington through the Department of Natural Resources entitled WHITMARSH/GAGES SLOUGH Project

Number 03-1190A signed by the Grantor on the 28th day of August, 2003 and by the State on the 8th day of August, 2003, and the application and supporting materials which are on file with the Grantor and the state in connection with the Project Agreement.

The Grantor will not make or permit to be made any use of the real property described in this deed, or any part of it, which is inconsistent with the right to use for public aquatic access herein granted unless the state, through the Department of Natural Resources or its successors, consents to the inconsistent use. Such consent shall be granted only upon conditions which will ensure that other aquatic access land, of at least equal fair market value at the time of change of use, and of as nearly as feasible equivalent usefulness and location for the public aquatic land access purposes for which state assistance was originally granted, shall be substituted for the original real property.

The real property covered by this deed is described as follows:

This deed shall in no way modify or extinguish the functions of the Grantor under the Project Agreement, including the Grantor's functions to operate and maintain the land as set out in the Project Agreement.

The rights and obligation of the state and Grantee shall be binding upon the respective successors and assignees.

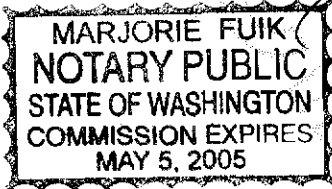

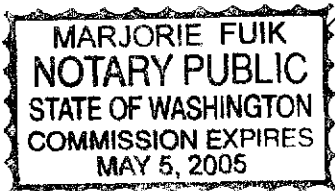
