That portion of Blocks 280 and 281, "MAP OF THE CITY OF ANACORTES, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 2 of Plats, page 4, records of Skagit County, Washington, of vacated Second Street and vacated alley through Block 280 and of tide land Tract No. 10 of Plate No. 9 of Anacortes tide lands, in Section 18, Township 35 North, Range 3 East, W.M., as per map filed in the Office of the State Land Commissioner, comprising the following described tract:

Beginning at a point on the North line of Third Street 171.6 feet East of the center of Avenue "V" as established in the City of Anacortes:

thence East along the North line of said Third Street 96.95 feet to the beginning of a curve to the left of 10 foot radius whose internal angle is 90° and whose tangent is 10 feet;

thence following said curve 15:71 feet to the West line of Curtis Drive as shown on the Plat of "CAP SANTE PARK ADDITION TO ANACORTES, WASHINGTON", as per plat recorded in Volume 4 of Plats, page 52, records of Skagit County, Washington;

thence North 0°34' East along said Curtis Drive and said Drive projected North, 468.63 feet, more or less, to the Inner Harbor Line as shown on Plate 9 of Anacortes tide lands:

thence North 89°15'45" West along said Inner Harbor Line 106.97 feet, more or less, to a point North 0°34' East of the point of beginning;

thence South 0°34' West 477.95 feet, more or less, to the point of beginning.
