LAND TITLE OF SKAGIT COUNTY EASEMENT AGREEMENT

JOINT MAINTENANCE PROVISIONS

THE GRANTORS, Howard Clark and Judy Clark, husband and wife, and Connie Clark, as her separate property, for and in consideration of Granting of Easement rights and no other consideration, convey to Fran Little, L.L.C., a Washington limited liability company, THE GRANTEE, and to its successors and assigns in ownership of the property described on Exhibit "B" attached hereto, a non-exclusive easement for ingress, egress and utilities over, under and across the following described tract:

As attached hereto as Exhibit "A"

Grantor and Grantee hereby covenant and agree, one with the other, that all maintenance and repair of the roadway described on Exhibit "A" attached hereto, and any future subdivision thereof, shall be shared between the parties hereto, their heirs, successors and assigns, in direct proportion to their relative use of said roadway.

The parties hereto further covenant and agree that should there be a disagreement as to the necessity of any maintenance or repair, each party shall select a licensed engineer, who together will select a third licensed engineer, and they shall determine whether the disputed maintenance or repair is required to maintain the roadway in a safe and passable manner. The costs of said engineers shall be born exclusively by the non-prevailing party.

The parties hereto further covenant and agree that this agreement shall be binding upon themselves, their heirs, successors and assigns and shall be a covenant running with the lands described herein.

This Easement Agreement With Joint Maintenance Provisions is executed the 6 day of December, 2004.
