SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INTEREST

The undersigned subordinator and owners agree as follows:

1. JEANETTE ROSE DIBIASE, as Trustee of THE JEANETTE ROSE DIBIASE REVOCABLE TRUST dated November 8, 1994, referred to herein as "Subordinator", is the owner and holder of a Deed of Trust dated January 31, 2001, and recorded under Auditor's File No. ~~20010130163~~, records of Skagit County, WA.
200101310163
2. ARGENT MORTGAGE COMPANY LLC, referred to herein as "Lender", is the owner and holder of a Deed of Trust dated 1/21, 2005, executed by KENNETH J. GINNETT and BOBETTA M. GINNETT, husband and wife, and recorded under Auditor's File No. 200501270088, records of Skagit County.
3. KENNETH J. GINNETT and BOBETTA M. GINNETT, referred to herein as "Owners", are the Owners of the real property described in the Deed of Trust identified in Paragraph 2.
4. In consideration of the benefits to "Subordinator" from "Owners", receipt and sufficiency of which is hereby acknowledged, and to induce "Lender" to advance funds under its Deed of Trust and all agreements in connection therewith, the "Subordinator" does hereby unconditionally subordinate the lien of her Deed of Trust identified in Paragraph 1 above to the lien of Lenders' Deed of Trust, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder.

including any extension or renewal thereof, but in any event, not to exceed the sum of \$90,000.00.

5. Subordinator acknowledges that, prior to the execution hereof, she has had the opportunity to examine the terms of Lenders Deed of Trust, Promissory Note and agreements relating thereto, consents to and approves same, and recognizes that Lender has no obligation to Subordinator to advance any funds under its Deed of Trust or see to the application of Lenders funds, and any application or use of such funds for purposes other than those provided in such Deed of Trust, note or agreements shall not defeat the subordination herein made in whole or in part.
6. It is understood by the parties hereto that Lender would not make the loan secured by the Deed of Trust in paragraph 2 without this agreement.
7. This agreement shall be the whole and only agreement between the parties hereto with regard to the subordination of the lien or charge of the Deed of Trust first above mentioned to the lien or charge of the Deed of Trust in favor of Lender above referred to and shall supersede and cancel any prior agreements as to such, or any, subordination including, but not limited to, those provisions, if any, contained in the Deed of Trust first above mentioned, which provide for the subordination of the lien or charge thereof to a Deed of Trust to thereafter execute.
8. The heir's, administrators, assigns and successors in interest of the Subordinator shall be bound by this agreement.

NOTICE: THIS SUBORDINATION AGREEMENT CONTAINS A PROVISION WHICH ALLOWS THE PERSON OBLIGATED ON YOUR REAL PROPERTY SECURITY TO OBTAIN A LOAN A PORTION OF WHICH MAY BE EXPENDED FOR OTHER PURPOSES THAN IMPROVEMENT OF THE LAND. IT IS RECOMMENDED THAT, PRIOR TO THE EXECUTION OF THIS SUBORDINATION AGREEMENT, THE PARTIES CONSULT WITH THEIR ATTORNEYS WITH RESPECT THERETO.
