NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- 1. John Jensen and Tina Jensen referred to herein as "subordinator", is the owner and holder of a mortgage dated April 26, 2004 which is recorded in volume of Mortgages, page under auditor's file No. 200404260124 , records of Skagit County. La Verne E. Krieger 2. referred to herein as "lender", is the owner and holder of a mortgage dated February 23, 2005 executed by Robin Moore, a married woman as her separate estate (which is recorded in volume of M auditor's file No. 20050303000113 records of Skagit of Mortgages, page County) (which is to be recorded concurrently herewith).
- 3. Robin Moore, as married woman as her separate estate referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
