On February 3, 2005, the Hearing Examiner entered Findings, Conclusions and Decision on the Special Use Permit application of Norm Wietting for Cimarron Transfer and Recycling Company. The Special Use Permit pre-decision hearing was combined with a hearing on an appeal for the SEPA Mitigated Determination of Non-Significance for proposal. The permit was approved, with conditions. The appeal was denied.

A Request for Reconsideration was filed by Roger E. Pederson, a party of record, on Monday, February 14, 2005, supplemented by a further communication filed on February 16, 2005 A second Request for Reconsideration was filed on February 14, 2005, by Rosemary Mann. Ms. Mann is also a party of record.

Both of these requests were timely. The 10 days for filing specified by SCC 14.06.180 terminated on a Sunday, so that requests received on the following Monday were acceptable.

After due considering of the filings made, the Examiner has concluded that the Requests for Reconsideration of Roger E. Pederson and Rosemary Mann should be denied and that the previous action should become final. Therefore both Requests are hereby **DENIED**.
