COMPANY, as Beneficiaries, who have assigned their interest to LANDS WEST, INC., a Washington Corporation. PETER A. MATTY has been appointed Successor Trustee.

II.

No action commenced by the Beneficiaries of the Deed of Trust is now pending to seek satisfaction of the obligation in any Court by reason of the Grantor's default on the obligation secured by the Deed of Trust.

III.

The defaults for which this foreclosure is made are as follows:

1. Failure to pay when due the following amounts which are now in arrears: Monthly installment payments of \$103.68 each for the months of February, 2004, through February, 2005, inclusive, which total \$1,347.84. Collection costs of \$5.00 each for the months of February, 2004, through February, 2005, inclusive, which total \$65.00. Late payment charge of \$10.37 each for the months of February, 2004, through February, 2005, inclusive, which total \$134.81. Plus monthly installment payments and late charges coming due after February 21, 2005.

2. The Grantor's failure to pay, prior to delinquency, the real estate taxes for the following years and amounts: 2004 - \$66.66, plus interest and penalties.

IV

The sum owing on the obligation secured by the Deed of Trust is Principal \$4,343.38, together with interest at the rate of twelve percent (12.0%) per annum as provided in the Note



or other instrument secured from the 31<sup>st</sup> day of January, 2004, and such other costs and fees as are due under the Note or other instrument secured, and as are provided by statute.

V.

The above-described real property will be sold to satisfy the expenses of sale and the obligation secured by the Deed of Trust as provided by statute. The sale will be made without warranty, express or implied, regarding title, possession or encumbrances on the 24<sup>th</sup> day of June, 2005. The defaults referred to in Paragraph III must be cured by the 13<sup>th</sup> day of June, 2005, which is eleven (11) days before the sale date, to cause a discontinuance of the sale. The sale will be discontinued and terminated if, at any time on or before the 13<sup>th</sup> day of June, 2005, the defaults as set forth in Paragraph III are cured and the Trustee's fees and costs are paid, along with any other costs, fees and advances made pursuant to the terms of the Note and/or Deed of Trust. The sale may be terminated anytime after the 13<sup>th</sup> day of June, 2005, and before the sale by the Borrower, Grantor, any Guarantor or the holder of any recorded junior lien or encumbrance paying the entire principal and interest secured by the Deed of Trust, plus costs, fees and advances, if any, made pursuant to the terms of the obligation and/or Deed of Trust and curing all other defaults.
