# STORM SYSTEM MAINTENANCE REQUIREMENTS COMMERCIAL SITE EXPANSION

for

## Fast Break Enterprises, LLC

- 1. ALL REQUIREMENTS HEREIN ARE THE RESPONSIBILITY OF THE PROPERTY OWNER. ALL WORK INVOLVING THE REMOVAL AND DISPOSAL OF DEBRIS FROM THE DRAINAGE SYSTEM MUST BE PERFORMED BY PERSONNEL LICENSED AND EXPERIENCED TO PERFORM THIS TYPE OF WORK. THE PROPERTY OWNER MUST KEEP A COPY OF ALL RECORDS INVOLVING CLEANING AND MAINTENANCE OF THE DRAINAGE SYSTEM. MAINTENANCE OF THE DRAINAGE SYSTEM SHALL INCLUDE ALL CATCH BASINS, STORM PIPES, AND THE DETENTION POND.
- 2. DURING ALL TIME PERIODS WHEN CLEANING AND FLUSHING OF THE STORM SYSTEM IS OCCURRING, THE OUTLET ENDS OF ALL PIPES ENTERING THE DETENTION POND SHALL BE TEMPORARILY WRAPPED WITH A LARGE FILTERING SACK TO CAPTURE ALL DEBRIS THAT WOULD OTHERWISE BE WASHED INTO THE DETENTION POND.
- 3. THE PROPERTY OWNER MUST CONTRACT WITH A COMPANY THAT IS SKILLED AND LICENSED TO PERFORM STORM SYSTEM CLEANINGS. A SCHEDULE MUST BE ESTABLISHED SO THE FOLLOWING EVENTS OCCUR:

#### MINIMUM ONE TIME PER TWO-MONTHS:

A) THE OWNER SHALL INSPECT. THE DETENTION POND FOR FLOATING DEBRIS, AND REMOVE IT. THE OWNER SHALL ALSO VISUALLY INSPECT EACH CATCH BASIN FOR FLOATING DEBRIS, AND REMOVE IT ALSO.

#### MINIMUM OF ONE TIME PER TWO & ONE-HALF YEARS:

A) CATCH BASIN SUMPS SHALL BE VACUUMED CLEAN OF ACCUMULATED DEBRIS.

### MINIMUM OF ONE TIME PER EVERY FIVE YEARS:

- A) STORM PIPES SHALL BE FLUSHED CLEAN PRIOR TO VACUUMING ALL STRUCTURES CLEAN OF ACCUMULATED DEBRIS.
- B) THE DETENTION POND SHALL BE CLEANED OF ACCUMULATED DEBRIS AND OVERGROWN VEGETATION.
