DECLARATION OF EASEMENT

This Declaration dated this 29th day of March, 2005, by Island Development LLC, a Washington Limited Liability Company is being made to amend and declare the public utility easement as shown and set forth on the face of the Plat of Windward Village according to the plat thereof, recorded June 14, 2004 under Skagit County Auditor's File No. 200406140129, records of Skagit County, Washington, pertaining to the exterior 10 feet of the lot, adjacent to the street, affecting Lot 3, Plat of Windward Village only.

As to the Ten (10) foot wide utility easement noted on the face of the Plat reserved for and conveyed to the City of Anacortes, Puget Sound Energy, Inc., Telephone Company, Cascade Natural Gas Company and Comcast Cable Television Company and their respective successors and assigns under and upon the exterior ten (10) feet of Lot 3, Plat of Windward Village lying parallel with, adjoining and adjacent to "D" Avenue, said easement shall be amended and declared to be a Thirteen (13) foot wide easement to accommodate the existing utilities as installed on or before March 29th, 2005. Said easement is solely for the purposes as set forth on the face of the Plat, "to construct, operate, maintain, repair, replace and enlarge underground pipes, conduits, cables and wires, all

necessary or convenient underground or ground mounted appurtenances thereto for the purpose of serving this subdivision and other property with electric, gas, telephone and other utility service, together with the right to enter upon the streets, lots, tracts and spaces at all times for the purposes herein stated."

Any and all other terms, conditions, rights or restrictions shown on the face of the plat as recorded shall remain in full force and effect as originally intended and as set forth therein.
