The maximum date for the line is extended to MARCH 28, 2015.


3. Your margin may increase or decrease as a result of your line increase.

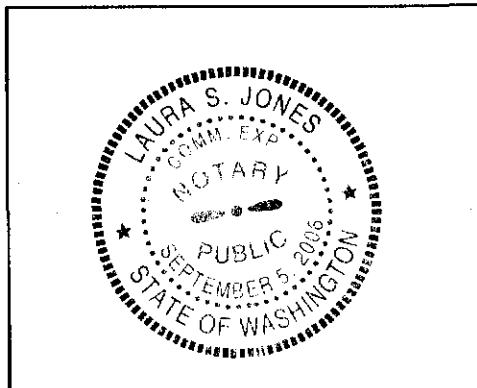

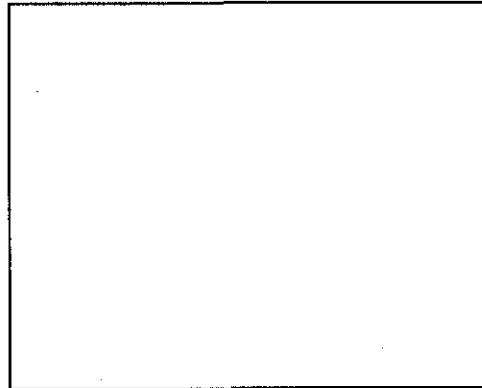
