## PARCEL A:

THOSE PORTIONS OF LOTS 1 AND 2 OF THE CITY OF BURLINGTON SHORT PLAT NO. SS 8-00, APPROVED AND RECORDED OCTOBER 10, 2001 UNDER SKAGIT COUNTY RECORDING NO. 200110100110 LYING EASTERLY OF THE FOLLOWING DESCRIBED LINE:

BEGINNING AT THE INTERSECTION OF THE MOST NORTHERLY LINE OF LOT 1 WITH THE MOST WESTERLY LINE OF LOT 2 OF SAID SHORT PLAT; THENCE NORTH 26 DEG 09 MIN 52 SEC EAST ALONG THE WEST LINE OF SAID LOT 2, A DISTANCE OF 19 FEET TO THE TRUE POINT OF BEGINNING OF SAID LINE; THENCE SOUTHERLY IN A STRAIGHT LINE TO A POINT ON THE SOUTH LINE OF SAID LOT 1 THAT IS 73 FEET WEST OF THE SOUTHEAST CORNER OF SAID LOT 1 AND THE TERMINUS OF SAID LINE.
