This agreement is entered into between Skagit State Bank (hereinafter referred to as "Lender") and the Northwest Business Development Association, a Washington nonprofit corporation, (hereinafter referred to as "NWBDA") this _8th day of July 2005.

WHEREAS, LENDER is the owner and holder of the following document authorized by Anderson Appliance Inc., (hereinafter referred to as Borrower):

UCC Financing Statement filed under Skagit County Auditor's Office Recording No. 200411080143 on November 8, 2004;

WHEREAS, NWBDA is about to make a Loan to Fortuna Properties, LLC and guaranteed by the Borrower in the principal amount of \$848,000.00. Said Loan is or will be secured by a Deed of Trust on the real property encumbered by the Lender's UCC Financing Statement recorded with the Skagit County Auditor's Office under Recording No. 200411080143 on November 8, 2004. NWBDA has declined to make the Loan to the Borrower without Lender first subordinating it's UCC Financing Statement described above to the Deed of Trust held by NWBDA and filed with the Skagit County Auditor's Office under Recording No. 200506160109 as security for said Loan.

NOW THEREFORE, in consideration of the foregoing premises, it is agreed as follows:

- Lender hereby subordinates the lien of Subordination. it's Financing Statement described above to the NWBDA's Deed of Trust filed with the Skagit County Auditor's Office under recording no. 200506160109. This subordination is limited to the \$848,000.00 face amount of the promissory note executed by borrower with respect to Loan No. CDC 698673-40-05 WA as of the date of the note, and thereafter to the declining principal balance, the interest rate as stated therein, the payment of any taxes, assessments, attorney's fees, insurance, interest and any other advances reasonably necessary to protect the property or any collateral securing the loan; the NWBDA's security interest(s) or the priority of the lien, and any extension of said Loan. This subordination does not apply 1 custom that the Lender has on the the lien to illuminated/electronic freeway message center pilon, 2 tower sign units, lighting strips and 4 awnings located on the property at 2520 Cedardale Road, Mount Vernon, Washington 98274.
- 2. Effect on Lender UCC Financing Statement. All other terms and conditions of the Lender's UCC Financing Statement shall remain in full force and effect.
- 3. Notification of Default. Lender agrees to furnish NWBDA, or its successors in interest, (1) written notice of any default by Borrower under the terms and conditions of its loan with Borrower within (30) days of the date of said default, and (2) in addition to any lawfully required notice, written notice of any foreclosure sale sixty (60) days prior to the date of said sale. This agreement shall be the sole agreement between the parties hereto with regard to the subordination of the lien of the UCC Financing Statement first above mentioned to the lien of the Deed of Trust in favor of NWBDA referred to herein and shall supercede and cancel any prior agreements to the same.
- 5. Binding Effect. This agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, successors and assigns.
