providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Insurance previously in effect, from an alternate mortgage insurer selected by Lender. Before each Change Date, the Note Holder will calculate my new interest rate by adding percentage points ( 4.125 The Note %) to the Current Index. Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.
