Real Estate Line of Credit Modification Agreement

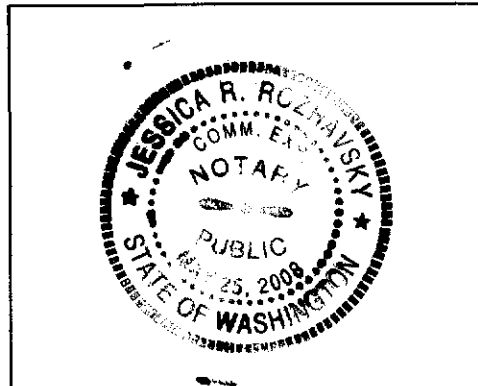

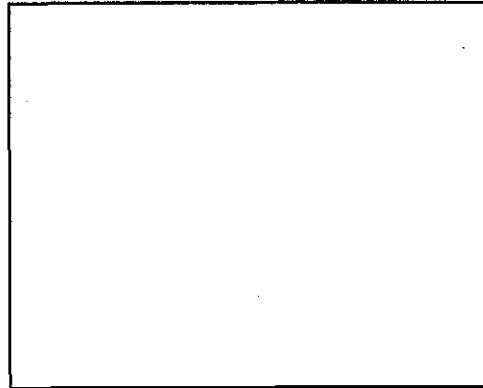
