The undersigned subordinator and owner agrees as follows:

- 1. DAVID R. HAMBRIGHT and MARY L. HAMBRIGHT, husband and wife referred to herein as "subordinator", is the owner and holder of a mortgage dated September 2, which is recorded in volume of Mortgages, page County. under auditor's file No. 200509080100 , records of Skagit SUMMIT BANK September 2, 2005 2. referred to herein as "lender", is the owner and holder of a mortgage dated executed by THOMAS S. NEWCOMER and JANET M. NEWCOMER, husband and wife of Mortgages, page (which is recorded in volume auditor's file No. 2005/090 8/2099 records of Skagit County) (which is to be recorded concurrently herewith).
- 3. THOMAS S. NEWCOMER and JANET M. NEWCOMER, husband and wife referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
