Deed of Trust

This real property is not used principally for agricultural or farming purposed, together with all the tenements, hereditaments, and appurtenances now or hereafter thereunto belonging or in any way appertaining, and the rents, issues and profits thereof.

To protect the security of this Deed of Trust, Grantors covenant and agree:

- 1. To keep the property in good condition and repair, to permit no waste thereof, to complete any building, structure or improvement being built or about to be built thereon; to restore promptly any building, structure or improvement thereon which may be damaged or destroyed; and to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the property.
- 2. To pay before delinquent all lawful taxes and assessments upon the property; to keep the property free and clear of all other charges, liens or encumbrances impairing the security of this Deed of Trust.

Should Grantors fail to pay when due any taxes, assessments, insurance premiums, liens, encumbrances or other charges against the property hereinabove described, Beneficiary may pay the same, and the amount so paid, with interest at the rate set for the in the note secured hereby, shall be added to and become a part of the debt secured in this Deed of Trust.

IT IS MUTUALLY AGREED THAT:

- 1. In the event any portion of the property is taken or damaged in an eminent domain proceeding, the entire amount of the award or such portion as may be necessary to fully satisfy the obligation secured hereby, shall be paid to Beneficiary to be applied to said obligation.
- 2. By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right to require prompt payment when due of all other sums so secured or to declare default for failure to so pay.
- If all or any part of the Property or any interest in it is sold or transferred without Beneficiary's prior written
 consent, Beneficiary may at her option, require immediate payment in full of all sums secured by this Security
 Instrument.

If Beneficiary exercises this option, Beneficiary shall give Grantors notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Grantors must pay all sums secured by this Security Instrument. The term Beneficiary shall mean the holder and owner of the note secured hereby, whether or not named as Beneficiary herein.
