## **GRANT OF EASEMENT**

ALDERBROOK 100 ACRE WOOD, L.L.C., a Washington limited liability company, hereby grants and conveys an easement over and across the property described in Exhibit "A" to ALDERBROOK COMMUNITY ASSOCIATION, a Washington non-profit corporation, and its individual members for the purpose of serving as an emergency vehicle turnaround. This is a non-exclusive easement and may be used as a portion of the driveway for the Lot 2-B, Short Plat PL02-0368, recorded under Skagit County Auditor's File No. 200210160145, as a driveway ("Servient Estate"); provided, the owner of the Servient Estate shall not park vehicles or place obstructions or improvements within the Easement that in any way impairs or interferes with its use as a turnaround for emergency vehicles.

This easement is perpetual and shall run with the land, and shall be binding upon the heirs, successors and assigns of the parties.



## Exhibit "A" to Grant of Easement Legal Description

An emergency vehicle turnaround easement in Lot 2B, Short Plat No. PL02-0368 recorded under Auditor's File Number 200210160145 over and through a strip of land 30 feet wide, the centerline of which is described as follows:

Commencing at the intersection of the north line of said Lot 2B with the east line of Alderbrook Lane as shown on said Short Plat; thence S 16°17′57″ W along said east line, a distance of 77.50 feet to the point of curvature of a curve to the right having a radius of 145.00 feet; thence southwesterly along said curve through a central angle of 37°04′22″ and an arc length of 93.82 feet to the initial point of this centerline description; thence S 36°37′41″ E, a distance of 15.00 feet to the end of this centerline description.
