heing the real property upon which the Claimant performed or caused to be performed the following activities:

Felling, bucking, yarding, loading, transporting and delivering of approximately 160 MILLION thousand board feet of white fir hemlock and Douglas fir saw logs, chip and saw logs and pulp logs from setting #SO0512.

The name of the owner or reputed owner of said real property is CASCADE TIMBERLANDS LLC (HAMILTON). Its agent, OLYMPIC RESOURCE MANAGEMENT, LLC, employed the Claimant to perform such labor and render such assistance upon the following terms and conditions: CASCADE TIMBERLANDS LLC (HAMILTON) agreed to pay the Claimant \$22.00 per ton on truck, plus a per ton delivery rate based on the point of delivery. Claimant has faithfully performed and fully complied with the agreement with CASCADE TIMBERLANDS LLC (HAMILTON), which performance commenced on or about March 15, 2005 and terminated on or about September 23, 2005 and sixty days have not elapsed since that time. The total amount of the Claimant's demand at the agreed price of \$22.00 per ton plus delivery is Four Hundred Twenty Four Thousand Nine Hundred Seventy Seven and 22/100 Dollars (\$424,977.22). There is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of TWENTY THOUSAND DOLLARS (\$20,000.00), together with attorneys fees of \$500.00 for the preparation of this Notice of Claim of Lien, for which Claimant claims a lien on all said real property or so much as may be necessary to satisfy this lien and judgment thereon.
