## **ORDINANCE NO. 3273**

### **AN ORDINANCE OF THE CITY OF MOUNT VERNON, WASHINGTON, VACATING CERTAIN PROPERTY AS PER PETITION FILED BY PUBLIC HOSPITAL DISTRICT NO.1**

**WHEREAS,** a petition has been filed pursuant to Chapter 35.79 RCW requesting that all of Montgomery Street between 13<sup>th</sup> Street and 15<sup>th</sup> Street; 14<sup>th</sup> Street south of Parcel No. 52962 to Montgomery Street; and all of the alley in the Green Street Addition be vacated, and

**WHEREAS,** the City Council of the City of Mount Vernon has on the 22nd day of June, 2005, conducted a public hearing in compliance with the provisions of the RCW 35.79.030, after notice as required by RCW 35.79.020, and

**WHEREAS,** the City Council finds that the below mentioned property is no longer required for public use, has no public benefit, there exists no public interest to be protected by retaining title to said property and that the City shall not require compensation for the vacation as the City shall receive public benefit from the expansion improvements made by Public Hospital District No.1 as a result of the vacation,

**NOW, THEREFORE,**

**THE CITY COUNCIL OF THE CITY OF MOUNT VERNON, WASHINGTON, DOES ORDAIN AS FOLLOWS:**

**SECTION 1.** The following described property which has been set aside by the City for street purposes is hereby vacated by the City to the abutting property owner and that the City excuses the abutting property owner from compensation as allowed by RCW 35.79.030.

#### **Parcel No. 1**

That portion of 14<sup>th</sup> Street lying Northerly of the North line of Montgomery Street as conveyed to the City of Mount Vernon by Bargain and Sale Deed recorded under Auditor's File No. 8412110021 and Southerly of the Easterly projection of the North line of Lot A, Short Plat No. MV-31-76, approved September 14, 1976 and recorded September 21, 1976 in Volume 1 of Short Plats, page 173, records of Skagit County, Washington.

That certain 18.00 foot wide North-South alley in the "Plat of Green Street Addition, Mount Vernon, Washington", as per plat recorded in Volume 7 of Plats, page 6, records of Skagit County, Washington.

The North 42.00 feet of the South 150.00 feet of Tracts 1 and 2 and of that portion of Tract 3 lying East of Thirteenth Street as established in the City of Mount Vernon of Dale and Shea's Addition to the City of Mount Vernon, as per plat recorded in Volume 3 of Plats, page 68, records of Skagit County; the North 42.00 feet of the South 150.00 feet of Tract "A" of Greenstreet Addition, Mount Vernon, Washington, as per plat recorded in Volume 7 of Plats, page 6, records of Skagit County; the North 42.00 feet of the South 150.00 feet of that portion of Fourteenth Street lying North of the original North line of Montgomery Street as vacated by City of Mount Vernon Ordinance No. 2124 dated July 11, 1984; the North 42.00 feet of the South 150.00 feet of Lots 14, 15 and 16 and Lots 11, 12 and 13 of said Plat of Greenstreet Addition to Mount Vernon, being the approximate, but not exact North 42.00 feet of both Lots 12 and 15; and the North 42.00 feet of the South 150.00 feet of that portion of the Alley lying between the North line of said original Montgomery Street and the North line of Lot 15, if projected Easterly, of said Plat of Greenstreet Addition to Mount Vernon as vacated by said City of Mount Vernon Ordinance No. 2124 dated July 11, 1984.




