THIS PLANNED UNIT DEVELOPMENT RIDER is made this JANUARY, 2006 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date, given by the undersigned (the "Borrower") to secure Borrower's Note to CHAPEL MORTGAGE CORPORATION, A NEW JERSEY CORPORATION (the "Lender") of the same date and covering the Property described in the Security Instrument and located at:

407 SPRING LANE, SEDRO WOOLLEY, WASHINGTON 98284 [Property Address]

The Property includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in covenants, conditions, and restrictions (the "Declaration"). The Property is a part of a planned unit development known as:

SPRING MEADOWS

[Name of Planned Unit Development]

(the "PUD"). The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and facilities of the PUD (the "Owners Association") and the uses, benefits and proceeds of Borrower's interest.
