WHEREAS, Grantor owns certain property located at 14850 Snee Oosh Road, La Conner, Washington 98257 and legally described on Exhibit A attached hereto ("Stafford Property"); and

WHEREAS, Grantee owns adjacent property located at 4898 Snee Oosh Road, La Conner Washington 98257, Skagit County, Washington and legally described on Exhibit B attached hereto ("Grantee's Property"); and

WHEREAS, Grantee wishes to use the existing stairs located on the Stafford Property for access to the beach and Grantor is willing to allow such use under the terms and conditions set forth herein,
