1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. Whether or not Borrower is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from deteriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that repair or restoration is not economically feasible, Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. be construed as a prohibition on the charging of such fee. Lender may not charge fees that are expressly prohibited by this Security Instrument or by Applicable Law.

Beginning at a point on the West line of said Lot 1 which is 364 feet South of the Northwest corner thereof; thence South 499.5 feet; thence East parallel with the North line of said lot to the Westerly bank of a slough running through said lot; thence Northerly along said slough to a point East of the point of beginning; thence West to the point of beginning, EXCEPT portion thereof, if any, lying within the old bed of the Skagit River, and EXCEPT roads.
