RIGHT OF FIRST REFUSAL

THIS AGREEMENT, made and entered into on the 7th day of March , 2006, by and between BAYVIEW LAND, LLC, hereinafter referred to as "Grantor," and JOHN PETH & SONS, INC., hereinafter referred to as "Grantee," as follows:

IN CONSIDERATION of Grantee's purchase, from Grantor, of the real property described in Exhibit "A" hereof, Grantor hereby gives, grants and conveys to Grantee a first right of refusal to purchase said property, on the same terms and conditions of any third party offer which Grantor is willing to accept. Upon receipt of such an offer to purchase from a third party, Grantor shall submit the same to Grantee who shall have ten (10) days in which to decide to purchase the subject property on the same terms and conditions as are included in the third party offer. Grantee shall have a first right of refusal as to each and every bonafide offer which Grantor chooses to accept.

This right of first refusal shall not apply to nor have any force and effect with respect to sales of segregated parcels of the afore-referenced property consisting of less than thirty-five(35) acres.

This right of first refusal shall not apply to any conveyances by Grantor to Jay Dee Peth or to any entities owned wholly or in part by Jay Dee Peth but shall be binding on subsequent conveyances to other successor(s) in interest.
