The undersigned subordinator and owner agrees as follows:

- 1. John and Marjorie Fuik referred to herein as "subordinator", is the owner and holder of a mortgage dated 2/16/2006 which is recorded in volume 4 of Mortgages, page under auditor's file No. 200602240162 , records of County. Skagit **Business Bank of Skagit County** 2. referred to herein as "lender", is the owner and holder of a mortgage dated executed by Matthew Click as manager of Westward Construction, LLC (which is recorded in volume of Mortgages, page auditor's file No. 200602240161 records of County) (which Skagit is to be recorded concurrently herewith).
- 3. Westward Construction LLC referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
