The North 1/2 of the South 1/2 of the Southwest 1/4 of the Northeast 1/4 of Section 31, Township 35 North, Range 2 East, W.M.

PARCEL "B":

A non-exclusive easement for ingress, egress and utilities over and across a strip of land 30 feet in width, being 15 feet on each side of the following described centerline:
