RECITALS:

WHEREAS, Grantor, is a Washington Special Purpose District responsible for ownership, repair, construction and maintenance of levees along the Skagit River for purposes of protection of life and property from flooding of the Skagit River within the boundaries of Skagit County Dike District No. 12; and

WHEREAS, Grantees are the current owners of real property as described above and on the attached Exhibit "A", and

WHEREAS, Grantor has previously been granted an access easement over and across the property of Grantees on December 5, 2000, under Skagit County Auditor's File No. 200012050027; and

WHEREAS, the parties hereto desire to vacate said easement, for purposes of relocating and granting a new location for said easement; and

WHEREAS, in exchange for Grantor vacating said easement, Grantees have agreed to contemporaneously convey a non-exclusive, mutually beneficial access easement for dike access and flood control, across, over and upon the lands and premises of Grantees.

NOW, THEREFORE, in consideration of the vacation of said easement, and the granting of a new relocated easement, under separate agreement to be contemporaneously recorded herein, Grantor hereby vacates, relinquishes, discontinues, and terminates said existing easement, located across, over and upon the lands of Grantees, as previously recorded under Skagit County Auditor's File No. 200012050027, and as legally described on Exhibit "A". Further, that in consideration of vacation of this easement, and the granting of a new relocated easement, Grantees hereby covenant and agree to indemnify and hold Grantor harmless from any and all loss, costs, damage, or injury caused by or arising out of Grantees' further use, ownership, and occupancy of said real property which is the subject of this Vacation of Easement.

An easement for access purposes over and across a 20 foot wide tract in a portion of Lot 20, HOPPER ROAD BUSINESS PARK SECOND REVISED BINDING SITE PLAN as recorded June 28, 2005 under Auditor's File No. 200506280192, records of Skagit County, Washington, the centerline of said easement being more particularly described as follows:

Beginning at the Southeast corner of said Lot 20;

thence North 07°50'01" West 62.00 feet along the Easterly line of said Lot 20 to the TRUE POINT OF BEGINNING of said easement centerline;

thence South 82°09'59" West 96.24 feet;

thence North 88°44'05" West 315.05 feet to a point of curvature;

thence along the arc of said curve to the right having a radius of 40.00 feet; through a central angle of 80°54'04", an arc distance of 56.48 feet to a point of tangency;

thence North 07°50'01" West 407.09 feet to a point of curvature;

thence along the arc of said curve to the left having a radius of 40.00 feet, through a central angle of 81°00'03", an arc distance of 56.55 feet to a point of tangency; thence North 88°50'04" West 62.58 feet to the Westerly line of said Lot 20 and the

terminus of said centerline.

The side lines of said easement are to be lengthened or shortened to intersect with the lot lines at each end of said easement.
