Respondent's motion and declaration for an order canceling the Lis Pendens filed and recorded by Petitioner, Deborah Falls, on 5/13/05, under Skagit County Auditor No. 200505130088, against the real property located at 13706 & 13700 Islewood Drive, Anacortes, Washington, which is solely owned by Michael Kelley, and for further sanctions pursuant to CR 37, the Court having heard argument of counsel, having reviewed the files and records herein, and being otherwise fully advised in the premises, now, therefore,

THE COURT HAVING CONSIDERED whether a lesser sanction would have

order was willful or deliberate and substantially prejudices Ms. Kelley's ability to prepare for trial, and

THE COURT FINDING FURTHER that the least severe discovery sanction that will adequately serve the purpose of sanctions, which are to deter, punish, compensate, educate, and insure that the wrong-doer does not profit from the wrong, are as follows:

## II. ORDER

it is HEREBY ORDERED, ADJUDGED, AND DECREED that the

following further sanctions are imposed on Deborah Falls:

- a) Ms. Falls is barred from supporting her claim and opposing Mr. Kelley' defenses; and she is prohibited from introducing any evidence supporting her claims or opposing Mr. Kelley's defenses, specifically regarding her claim that they acquired certain property together (paragraph 2.1 of the Petition), and for breach of contract (paragraphs 3.1, 3.3, 4.1, and 5.1 of the Petition)
- b) In the alternative, paragraphs 3.1, 3.3, 4.1 and 5.1 of Ms. Falls petition are stricken, the action dismissed, or, a judgment for default shall issue against

IT IS FURTHER ORDERED that the Lis Pendens filed and recorded by Petitioner, Deborah Falls, on 5/13/05, under Skagit County Auditor No. 200505130088, against the real property located at 13706 & 13700 Islewood Drive, Anacortes, Washington, at the outset of this case, is canceled.
