The Glendon Biofilter, which is installed on the property referenced above, requires perpetual operation and monitoring (O&M) for the life of the system. O&M shall be provided by an entity acceptable to the Skagit County Health Department (SCHD).

1. The O&M manual provided by the Glendon Biofilter distributor shall be followed.
2. Right of entry shall be provided to the property for the purpose of inspection, monitoring, maintenance, operation and sampling.

3. The Glendon Biofilter owner (grantor) shall obtain approved O&M for the life of the system and assure that O&M service visit reports are provided to SCHD.
4. The Glendon Biofilter owner (grantor) shall notify prospective purchasers of the requirements for perpetual O&M of the Glendon Biofilter.
5. Failure to renew an O&M contract is considered noncompliance with the On-site Sewage System (OSS) permit conditions. This is equivalent to an OSS failure, which will result in enforcement action by SCHD.

These agreements shall run with the land and shall be binding on all parties having or acquiring any right, title, or interest in this land described herein or any part hereof, and it shall pass to and be for the benefit of each owner thereof.

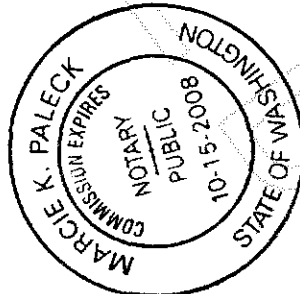
